Mayor Christopher Jackson called the regular meeting of the Walhalla City Council to order, 7:00 P.M., Monday December 2, 2013 at City Hall.

Moved by Lee to approve minutes of November 4, 2013, second by Horgan. Ayes: All, Nays: None. Motion carried.

Alderman Gapp spoke to the Council on the need to replace the body armor for the police, also the need for uniforms. Moved by Belanus to approve of the armor and uniforms for police, second by Horgan. Ayes: Karel, Horgan, Lee, Belanus and Gapp. Nays: None.

Moved by Lee to approve a \$400,000.00 buy down for the bonds and to reissue bonds, second by Karel. Ayes: All. Nays: None. Motion carried.

Moved by Belanus to appoint David Carignan to the Airport Authority to replace Greg Porter, second by Horgan. Ayes: All, Nays: None. Motion carried.

Kathy spoke to the Council regarding Walhalla Ag Service. David Carignan and Jayden Rollness is purchasing Walhalla Ag Service from Greg Porter. Kathy explained to the Council the Pace Program for buying down the interest on their loan. Moved by Karel to approve the interest buy down for the loan, second by Lee. Ayes: Karel, Horgan, Lee, Belanus and Gapp. Nays: None. Motion carried.

Three bids on the 1998 Freightliner Tractor Truck were opened, Moved by Gapp to accepted Greg Hornungs' bid of \$2000.00, second by Horgan. Ayes: All, Nays: None. Motion carried.
