Moved by Horgan to approve minutes of November 7, 2011 as read. Second by Volk-Schill. Ayes: All, Nays: None. Motion carried.

Moved by Solberg, second by Jackson to transfer \$125,000.00 from Sales Tax Fund to Economic Development Fund.

Moved by Jackson, second by Karel to transfer \$2,000.00 from Sales Tax Fund to Social Security Fund.

Moved by Jackson, second by Horgan to transfer \$25,000.00 from Civic Center Fund to Swimming Pool Fund.

Moved by Horgan, second by Jackson to transfer \$8,933.00 from ADM Water Fund to Library Fund.

Moved by Solberg, second by Jackson to transfer \$75,000.00 from Sales Tax Fund to Highway Distribution Fund.

Council decided to put the Civic Center Sale Money into CD's

Moved by Jackson to approve the Financial Report as presented. Seconded by Horgan. Ayes: All, Nays: None. Motion carried.

Health Committee: With all the complaints on some animals in City Limit, the Council will revise the Ordinance pertaining to animals. The first reading will be next month.

Streets and Alleys: Moved by Jackson, second by Volk-Schill to purchase a reversible snowplow for the truck in the amount of \$7,600.00. Ayes: Volk-Schill, Ermer, Jackson, Solberg, Horgan and Karel. Nays: None. Motion carried.

Council had a lengthy discussion with Gordon Johnson on the water rate increase for the North Valley Water Contract. Moved by Solberg to sign the new contract, for lack of second, motion died. North Valley will be meeting on the 15<sup>th</sup> of December.

Mayor Jackson met with the County Commissioners to revisit the contract between the County and City regarding police. County proposed a 15,000.00 a year contract paying quarterly. Moved by Solberg to accept and sign agreement, second by Karel. Ayes: All, Nays: None. Motion carried.

Moved by Karel, second by Volk-Schill to approve the call for bids for a police car. Ayes: All, Nays: None. Motion carried.

Clinic was discussed and tabled until more information is available.

Moved by Karel to pay all bills presented, second by Volk-Schill. Ayes: Volk-Schill, Ermer, Jackson, Solberg, Horgan and Karel. Nays: None. Motion Carried.

Contract for Deed regarding the building being bought by Sarah Thornberg was discussed by Larry Dubois. Moved by Solberg, second by Volk-Schill to accept the Contract for Deed. Ayes: All, Nays: None. Motion carried.

City Council discussed with Frank Schill, Kelly Gratton the Truck Route Ordinance. Council decided not to revoke the Truck Ordinance, but to revise the current Ordinance. Tabled until next month.
