The Pembina Gorge extends from the Canadian border throughout Cavalier County, encompassing most of the largest uninterrupted block of woodlands in North Dakota, approximately 12,500 acres and the longest segment of unaltered river valley in the state. Surging waters carved the Pembina Gorge out of soft marine shale, creating one of our deepest and steepest river valleys in North Dakota. In this rugged and sheltered setting, an enormous swath of forest is nestled in a transition zone where three different bio geographical provinces come together boreal forest, ester deciduous forest and central grassland.

The Pembina Gorge is home to the most extensive oak woodland in the state, the most extensive wetland thickets and notable avifauna density, the greatest development of birch woodlands, the least locally disturbed river system, the largest collective area and greatest association number of upland shrub lands.

At least 65 different naturally diverse features were documented to be in the Pembina Gorge, including 30 plant species and 21 animal species, which are categorized as being "rare" in the state.

Rendezvous Region Backway travels between Cavalier and Vana meandering the Pembina River Gorge.

Located in northeast North Dakota is a special place steeped in history, with natural resources, recreation, scenic beauty, and culture. Winding along the bends of the Pembina River you can enjoy the panoramic view of the Pembina Gorge along with the year-round recreational opportunities of the area. Beginning on Highway 55 in Vang proceeding east to Walhalla, turning southeast for 22 miles traveling past Icelandic State Park to Highway 5 ending in Cavalier. walhalland.org or parkrec.nd.gov/byways/rendezvous/rendezvous.html



Geology and Prehistoric Life of the Rendezvous Region

The Rendezvous Region is one of the most scenic areas in the state, and it is also one of the most interesting areas from geological and paleontological perspectives. The oldest rocks in North Dakota are exposed in the Pembina Gorge and North Dakota's oldest fossils are found in those rocks. The rocks and fossils entombed in them provide evidence that shallow seas from about 90 to 80 million years ago covered North Dakota and that these seas were teeming with life. https://www.dmr.nd.gov-/ndfossil/education/trunks/Trunk%20030609.html

Pembina Gorge Snowmobile Trail System

Snowmobilers also find this an exciting vacation spot. The Pembina Gorge Trail System has over 700 miles of state groomed trails. The views along these trails are anything but ordinary. When one thinks of the flat, open lands of the region, this hilly area is breathtaking, during the winter season, with warming houses stationed along the trail system. The Pembina River is ND's only "white water river" The meandering river is considered tame, but does offer excellent canoeing in its secluded landscape. Canoe access docks are located at Vang Bridge, Brickmine Bridge and Walhalla. Wildlife viewing, birding and scenic landscape is a bonus. Pembina Gorge State Park 701-549-244

Masonic Scenic Overlook, Walhalla

The scenic overlook has an elevation of 1,155' above sea level. The vista overlooks the beautiful Pembina River and the Pem bina Hills. Following the road west will take you to the Tetrault Wood Overlook. The minimal maintenance dirt road is excellent for hiking, biking and horseback riding.

Tetrault Woods State Forest and Scenic Overlook, Walhalla

The Tetrault Woods State Forest is located on State Hwy 32 and the Scenic Overlook is located west of Walhalla on County Rd. 55. The forest provides a diversity of trees, water and wildlife resources. It preserves part of the riparian forest typical of the Pembina River, with bur oak, ash, elm, birch and aspen as the common forest species. The Tetrault Woods State Forest was established in 1970 and covers 432 acres. Non-motorized trails area available throughout the forest. Hikers, bikers and horseback riders enjoy many of the pathways leading to the Pembina River and the Pembina Hills from the Tetrault Woods. Oxcart Trails of the Rendezvous Region Backway **Traveling the Highways of 1800-1870**

Métis used the first oxcarts about 1800. It is thought that the idea for the cart was brought by the fur traders of Eastern Canada and patterned after a cart used in France. It was developed by the Métis and became the vehicle for transportations and commerce between the Red River Settlements and St. Paul, MN between 1800 and 1870. The cart was made entirely of wood. The wheels were about 5' high and 3' wide and 5'or 6' long. The wooden hubs and axles were never greased since; under normal use dust gathered in the axle grease and would guickly wear down the wooden parts. At first the wheels were made of one solid piece of wood; later, spokes were used. The squeal of the grinding wood axle and hub could be heard for miles. Each cart could carry from 800 to 1,000 lbs. A single ox could travel about 20 miles in a ten-hour day. The carts could be converted into makeshift rafts to cross-rivers. By 1820 there were approximately 540 carts in use. By 1840 it is estimated that there were as many as 5,000 carts traveling the trails between the Red River Settlements and St. Paul, MN.

Icelandic State Park is located on the north shore of Lake Renwick. Icelandic State Park offers visitors not only a wide array of recreational opportunities, but also a glimpse of North Dakota's homesteading heritage and natural beauty. Boating, swimming and fishing for northern pike and other game fish are popular activities. Picnic areas offer visitors a relaxing afternoon in the shade of old oak trees, while the campgrounds have full amenities, including electrical hookups, modern comfort stations with showers and sewage dump station. Three sleeping cabins are also available from mid-May through the end of September.

Within the park is the Pioneer Heritage Center and restored historic buildings. Also found here are the Gunlogson Homestead and Nature Preserve. This early homestead preserves the state's pioneer spirit, while the 200-acre natural wooded area along the Tongue River is a sanctuary for plants, birds and wildlife. 701-265-4561 www.parkrec.nd.gov/parks/isp/isp.htm

Dean C. Hildebrand WMA: 280 acres; 1 ½ miles east, 1 mile north, 1 mile east of I-29 Exit 191; moose, elk, deer, waterfowl, sharp-tails, Huns, fishing.

Barron WMA: 386.10 acres; 1 mile east of I-29 and Exit 208; moose, elk, deer, waterfowl, sharp-tails, Huns, fishing.

Billings WMA: 160.90 acres; 2 miles east, 2 miles south, and 1 mile east of I-29 and Exit 200; moose, elk, deer, sharp-tails, Huns.

Clifford WMA: 80 acres; 2 ½ miles south, 6 miles east, 2 miles south, and ½ mile east of Walhalla; elk, deer, ruffed grouse, snowshoe hare.

Duncklee WMA: 151.90 acres; 3 miles east of I-29 and Exit 196; moose, elk, deer, waterfowl, sharp-tails, Huns, fishing.

Eldon S. Hillman WMA: 160 acres; 6 ½ miles west of Cavalier; moose, elk, ruffed grouse.

Eyolfson WMA: 23 acres; 1 mile west, and 1 ½ miles north of Hensel; ruffed grouse.

Fitzsimond Slough WMA: 415 acres; 4 miles east, 1 mile north, and 1 mile east of Walhalla; moose, deer, sharp-tails, Huns,

Jay V. Wessels WMA: 3,382 acres; 7 miles south, and 3 miles east of Walhalla; moose, elk, deer, ruffed grouse, turkeys, snowshoe hare, tree squirrels.

Peter and Prescott Holman WMA: 160 acres; from Junction of HWY 5 and HWY 32: 4 miles north, 6 miles east, 1 mile north, ¼ mile west, and 1 mile north; moose, elk, deer, turkeys, snowshoe hare, tree squirrels.

Rene WMA: 40 acres; 1 ½ miles east of I-29 and exit 208; deer, sharp-tails, Huns.

Steinke WMA: 80 acres; 1 ½ miles east of Neche; deer, sharp-tails, Huns.

Cavalier County WMA - 1,433 acres; several tracts located about 3 miles southwest of west junction ND 5 & ND 32. Deer, snowshoe hare, ruffed grouse, moose, elk.

Pembina Hills WMA - 4,678 acres; several tracts located about 4 miles north and 13 miles west of Walhalla and 5 miles west, 4 miles north, 1 mile west and 1 1/2 miles north of west junction ND 5 & ND 32. Deer, ruffed grouse, snowshoe hare, moose, elk. Wilbur Allen WMA - 682 acres; 13 miles north and 9 1/2 miles east of Langdon. Deer, moose, ruffed grouse, snowshoe hare. (No centerfire rifles allowed).

Charles V. Pulver WMA: 1,162 acres; 12 miles east, 2 ½ miles north, 2 miles east, and 3 ½ miles northwest of Langdon; moose, elk, deer, ruffed grouse

Goschke Dam in the Busse Coulee in Pembina County, North Dakota used for flood control purposes. Construction was completed in 1958. Its normal surface area is 19.9 acres. It is owned by Pembina Co Wrd

Mount Carmel Dam is on the Little South Pembina River in Cavalier County, North Dakota used for recreation and drinking water purposes. Construction was completed in 1971. It has a normal surface area of 386 acres. It is owned by Cavalier Co Wrd.

Renwick Dam/Icelandic State Park on the Tongue River in Pembina County, North Dakota used for flood control and recreation purposes. Construction was completed in 1962. At normal levels it has a surface area of 204 acres. It is owned by Pembina Co Wrd.

Senator Young Dam

Is impounded by Senator Young Dam on the Tongue River in Cavalier County, North Dakota used for flood control and drinking water purposes. Construction was completed in 1961. It has a normal surface area of 38.5 acres. It is owned by Pembina Co Wrd.

Pembina Gorge State Recreation Area

Multi Use Trail System- Motorized and Non-Motorized Trails While designed for the use of OHVs it is also open to hikers, mountain bikers and horseback riders. The trail is made possible through the North Dakota Park and Recreation Department's partnerships with state agency and private landowners.
